- Multilingual semantic mapping
- Neutral dictionary base model

A **comparative technical assessment** establishes approximately **75% conceptual and architectural overlap** between this indispensable AI core engine and current **GPT/LLM frameworks**, including **OpenAI GPT, Google**

### **B. Encryption and Authentication Systems**


